

The speaker says: "Living abroad is not difficult and <u>many people enjoy taking advantage of the opportunities to live and work overseas</u> and other things of what you can gain from broadening your horizons." Therefore, a lot of people appreciate living in a foreign country.

Ross says: "[...] I have been living in Linz in Austria, for well - since September, so around six months, again as part of my university course." Therefore, spending time abroad belongs to the academic programme.

Ross also says: "Firstly that, of course, the language benefits are unbelievable. I mean, my ability to speak German – and have sort of everyday conversation – really –as opposed to talking about the big politics that you learn in school." Therefore, the speaker is more confident when using the language on a daily basis.

Josh says: "[...] apart from the obvious language benefits, <u>living abroad looks really good on your CV, I mean - future employers – I've been told that future employers always like to see people who are worldly and cultured.</u>" Therefore, living abroad will probably help when applying for a job.

Then Josh says: "Another thing that I would say is really good is the fact sometimes when you go abroad as an English speaker – or as a speaker of a foreign language you get paid a lot more than you would be paid in the UK simply because you have this natural language skill that you can then pass on to other people." Therefore, for English speakers the salary can be much better than at home.

Josh also says: "I've also found living abroad to be a lot cheaper, as someone who lives in London and has been paying up to £1,000 per month for rent it is really refreshing to come to a country like Austria and end up paying somewhere between €250 and €350 a month for rent." Therefore, the speaker likes the fact that less of his income is spent on accommodation.

The speaker says: "So I was doing my college applications on the carpeted stairs of our unfurnished apartment." Therefore, Simpson was filling in her college applications.

1

The speakers say: "Mom, am I anything? What do you mean? Well, it says Asian-American, African-American, Hispanic, Native American. Does it say Syrian or Arabic-American? No. Well, just leave it be then or you can write in Syrian. <u>I left it be</u>." There was no correct option for her on the form, so therefore Simpson left it be.

2

The speaker says: "Then a few minutes later I called down, 'Do I <u>need financial aid?</u>" After a short time, Simpson therefore asked her mother if she needed financial aid.

3

The speaker says: "But we'd always needed money, we'd always been short of money. [...] We lived in an, literally in an unfurnished apartment with no furniture in it and we had had the gas and electric turned off more than once." As Simpson and her mother had little money, their home therefore was unfurnished or often without gas or electricity.

#### 4

The speaker says: "My mom had even sent me to the landlord to encourage them to give us an extension on our rent." Therefore Simpson had to ask for more time to pay the rent.

The speaker says: "So one night in November my mom drove us up to their house [...] and my mom waited in the car while I went inside." Therefore Simpson walked into the house and her mother waited in the car.

#### 6

The speaker says: "Misses Haley answered the door [...] and she led me to the kitchen counter where the Tin Man was sitting [...] and she asked me how I <u>was doing in school</u> and I said, 'Good'." Therefore the landlord's wife wanted to know how Simpson was doing in school.

#### 0

The speaker says: "Whether you are nine or ninety you are certain to take pleasure in a visit to Walt Disney's magic kingdom theme park in Orlando. The Magic Kingdom is indeed a <u>magical place</u> with marching bands, colourful Disney characters, dazzling daily parades, spectacular fireworks and innovative attractions." Therefore, Disney Orlando fascinates people of all ages because they come to a magical place.

## 1

The speaker says: "If you have children, bring along <u>an autograph book</u>. There are many Disney costumed characters at the park and they happily dispense hugs, sign autographs and pose for pictures with all visitors to the magic kingdom." Therefore, if you come with kids, make sure they have an autograph book.

## 2

The speaker says: "It's also advisable to start out early in the day as soon as the park opens. Guests who stay at Disney hotels gain <u>early entrance</u> into the parks which is helpful to avoid the lines which get longer as the day progresses." Therefore, staying at a theme park hotel gives you the advantage of early entrance.

## 3

The speaker says: "The most popular attractions have <u>a fast pass</u> which allows guests to receive <u>a return time</u> to see a popular attraction. You simply insert your ticket into the fast pass kiosk and go to another attraction and return at the time on your <u>fast pass</u> without waiting." Therefore, to visit the highlights, without standing in line, you can get a fast pass or a return time.

#### 4

The speaker says: "Welcome to the train station on Main Street. [...] The train station is also the place where the maps of the Magic Kingdom are located. Be sure to pick one up before you leave the station. Check inside the map for the white and green times guide and information sheet. This times guide lists the times for special shows, attractions, restaurants and dining with Disney characters." Therefore, at the station, so that you can plan your visit, it is best to get a map.


## 5

#### 0

The speaker says: "Women are forbidden from getting behind the wheel there. Just last month a woman tried to drive from the United Arab Emirates into Saudi Arabia and she was promptly arrested." Therefore, a woman was put in prison for driving from one Arabic country to another.

#### 1

The speaker says: "I wasn't allowed - because I'm a woman. I grew up in a small, densely populated village in upstate New York called Kiryas Joel. And in Kiryas Joel, women don't drive. It's a village of ultra-Orthodox Hasidic Jews." Therefore, in her home village, Goldberger was unable to drive because of her religious background.

#### 2

The speaker says: "A woman who drives would <u>risk being shunned</u>, and her children expelled from the private Hasidic school. <u>She could be excommunicated from the community</u>." Therefore, female drivers in Goldberger's village might be banned from their religious group.

#### 3

The speaker says: "My husband and I eventually left the community to explore a less restrictive Jewish lifestyle, and I got my driver's license." Therefore, when Goldberger moved away from her home village, she was able to get official permission to use a motor vehicle.

## 4

The speaker says: "I wasn't thinking about this when I made my first long-distance drive to New York City with two female friends from Kiryas Joel. I had borrowed a GPS and got on the road with my old, tan Buick. It was dark when we started to head back — not ideal for a new, timid driver." Therefore, the first time Goldberger took her car on a longer trip she had to return by night.

# 5

The speaker says: "Suddenly, without warning, cars started coming at me at the opposite direction. I had steered into oncoming traffic. I froze. I saw my father pointing an accusatory finger at me. I saw death." Therefore, in a critical situation Goldberger imagined her father blaming her for the consequences of her actions.

## 6

The speaker says: "Five minutes later, after I honked and blinked my lights furiously, the cars came to a standstill to allow me to back out of the mess." Therefore, other drivers had to stop before Goldberger was able to continue her journey.

The speaker says: "My driving has been relatively <u>uneventful since</u>. A few fender-benders here and there, but <u>my children and I are still alive and well</u>." Therefore, from that day on Goldberger used her car without putting anyone in danger.
